Terms & conditions:

1. The appointment will be purely on contract basis and the incumbent shall have no legal right to claim his/her regularization/appointment by absorption or otherwise against any regular posts or any further contractual engagement on termination of the scheme/project. Since appointment of SRFs/RA is for full time, they will not be allowed to do any other work or to accept or hold another appointment with or without remuneration elsewhere.
2. The term of appointment will be co-terminus with the period of the project or earlier based on the performance of the candidate. Non-maintenance of the discipline or failure to perform the duties assigned will make the SRFs/RA liable for termination.
3. No accommodation will be provided
4. No TA/DA will be provided to any candidate for attending the interview.
