It will be opened and all the documents will be scrutinized. Absence of any document listed in above and originality of tender forms may be rejected/will be considered as non-eligible and in such case Envelope No. 2 will not be opened.

#### **Envelope No. 2: (Price Bid)**

If possible, eligible Envelope No. 2: (Price Bid) may be opened on the same day or any other date and time which will be communicated at the time of opening of Envelope No.1 of tender. The University authority will decide the date and time for opening Envelope No. 2.

### **4) EARNEST MONEY-**

## **5) SECURITY DEPOSIT (SD) -**

The successful tenderer whose tender is accepted will have to remit Security Deposit (SD) @ 3% of the tender value within 10 days from the date of giving such order and it has to be paid in the form of Demand Draft from Nationalized/Scheduled Bank only in the name of Asstt. Comptroller, CDF, Wani Rambhapur. Failure of which EMD will be forfeited and supply order will be treated as canceled and order will be placed with other party/parties either from tender or from open market and the excess expenditure incurred by University shall be recovered from defaulting party. With the consent of the contracted party, EMD will be converted in to Security Deposit (SD). The Security Deposit would be retained up to the validity period of the contract and will be refunded thereafter without any interest and after completion of office procedure.

## **6) RATE OFFER -**

- a) The rates should be offered for the items in **Annexure-“ A”** for Centers/Locations mentioned.
- b) Rate should be offered inclusive of all Taxes i.e. VAT, Turnover Tax, Modvat etc and Duties i.e. Excise, Spl. Excise, Cess etc. The conditional offer will not be accepted OR printed terms and conditions on letter head of tenderer will not be binding in this tender.
- c) The Dealer has to indicate discount rate/amount offered.

b) The Order for quantity can be increased or decreased depending on requirement.
