 immediately contact to office of the University Engineer before date of closure of issue of forms. No claim will be entertained in this regard thereafter.
- 2. The details of work and details of terms & conditions of tender can be seen in the office of the University Engineer Dr. PDKV, Akola in working hours.
- The earnest money will be accepted in the form of TDR/FDR for a period of 12 months issued by any Nationalized / Scheduled Bank & in the name of The University Engineer,
 Dr. PDKV, Akola (In envelope No.1). No exemption shall be allowed in this regard, except the Contractor Registered under Unemployment Engineer Scheme vide GR No.
 CAT1090/CR21 EMA-2 Mantralaya Mumbai 400 032 Dt. 7 Sept. 1995 & EMD exemption certificate issued by the PWD/CPWD.
- 4. The Contractors shall enclose a latest attested true copy of Income Tax Return and attested true copy of Pan Card in envelope No.1.
- The Contractor shall enclose an attested true copy of valid Registration Certificate as approved contractor in the appropriate category of class with P.W.D., CPWD/MJP in envelope No.1.
- 6. The Civil Contractor shall enclose the attested copies of valid Electrical Registration & Licence in support for Electrical work included in civil work in Envelope No.1.
- Rate analysis must be given with signature of contractor within 2 days after opening of the tender if the rates quoted are more than below 15%. If the submitted rate analysis is not justifiable or found vauge, tender will be rejected.
- 8. Separate envelope shall be submitted for Technical and Financial Bid numberd as 1 & 2, respectively
- 9. The rates quoted by the Contractor shall be valid for 120 days from date of opening of tenders.
- 10. The right to reject any or all tenders without assigning any reason thereof is reserved by Competent Authority of the University.
- 11. The amount of Income Tax, GST, Royalty & Insurance will be deducted from each running bill as well as final bill of the work done by the Contractors bill as per rule. If Govt. lavies any other Tax except above Taxes by the period of execution same will be deducted from the bills of Contractors.
- 12. Conditional or incomplete Tender will not be accepted in any case.

If the tenderers delays for completing the formalitie as stated above, his tender will be rejected & the offer will be given to next lowest tenderer.
- 15. The total amount of 1% cess of the Agreement cost will be deducted from the only 1st R.A. & first & final bill of the Contractor.
- 16. The Contractor having three works of the Dr. P.D.K.V., Akola University in hand shall not be eligible for submission of 4th Tender.
- 17. Contractor will have to deposit Additional Security Deposit (performence security) as per G.R. at the time of submission of tender otherwise their EMD Amount will be forfeited.
