Applicant should be an active scientist up to the age of 55 years and should have made outstanding contribution in the concerned field of Agriculture/ Animal Sciences /Fisheries or Agricultural Engineering while working in India.

REGULATION REGARDING “DR.P.S. KHANKHOJE GOLD MEDAL”

In exercise of the power conferred under Statute -92 of the Maharashtra Agricultural Universities (Krishi Vidyapeeth) Act, 1983, the Executive council on the recommendations of the Academic council makes the following regulation namely,

REGULATION NO. EC/82

1. Short Title The regulation may be called “ Dr. P.S. Khankhoje Gold Medal” Regulation.
2. Definations In this regulation unless the context otherwise requires:-
 - (i) “Act” means the Maharashtra Agricultural Universities, Krishi Vidyapeeth Act 1983;
 - (ii) Words and expressions used in the Act , Statute and Regulations and not defined in this regulation shall have the meaning assigned to them in the Act, Statute and Regulation as the case may be.
3. Donors object and institution of the prize As desired by Shri Sunil Khankhoje, Secretary of Dr. P.S khankhoje Smarak Samitti, herein- after called the donor in this regulation, the university hereby institutes an award of a gold medal to commemorate the memory of Dr. P.S. Khankhoje, a well known freedom fighter and an agricultural scientist. A gold medal will be awarded to the out standing research worker at all India level, who is adjudged to have done outstanding research in the disciplines of agriculture including animal sciences, Fisheries and agricultural engineering.
4. Amount of donation and manner of its investment The amount of Rs. 300,000 (Three lacks) donated by the donor shall be invested in the fixed deposit of any scheduled bank in the name of the university by comptroller under intimation to the executive council.
5. Accounts A separate account of all deposits and other transactions in this behalf shall be kept by Comptroller of the university.
6. Utilization of the proceeds of the interest on investment (1) From out of the gross receipts accruing on account of the total amount invested as referred to in paragraph 4, of this regulation, at the commencement of every financial year, an amount equivalent to 20 per cent of the gross receipts shall be credited to the university fund as management charges, and 20 per cent of the gross receipts will be deposited in the principle amount in order to raise the principle amount and the balance of the gross amount will be utilized towards the cost of the gold medal. After the payment for the gold medal, the balance if any, of the net receipt shall be credited to the separate account referred to paragraph 5.
 - (2) The words “Dr. P.S. Khankhoje Gold Medal” and the year of the award shall be inscribed in English on the face of the medal and the dorsal side of the medal shall be inscribed by the words “Dr. Panjabrao Deshmukh Krishi Vidyapeeth, Akola” and the emblem of the university.
 - (3) The initial cost for preparation of the mould to facilitate casting of the medal shall be borne in full by the university. The mould thus prepared shall be property of the university and shall remain in the custody of the Registrar.
 - (4) The 6th medal shall be awarded from the year 2016-2017.

7. Selection of the awardee
- (1) The selection committee of the following members will select the outstanding research worker from the all India level
- i) Hon'ble Vice-Chancellor -- Chairman
 - ii) One Scientist from the disciplines of agriculture -- Member
 - iii) One Scientist from the discipline of Animal Science -- Member
 - iv) One Scientist from the discipline of Fisheries -- Member
 - v) One Scientist from the discipline of agricultural Engineering -- Member
 - vi) Registrar -- Secretary
- (2) The persons under category (ii) to (v) mentioned in clause 1 above shall be nominated by the Vice-Chancellor for a period of not exceeding one year at a time.
- (3) As early as possible after 31st May but in case before the 31st August, each year the Registrar for information of all the scientist shall publish a notice in the manner determined by the Vice-Chancellor inviting applications in the prescribed proforma as appended to this regulation as Appendix I from them for consideration of the award of gold medal.
8. Vice-Chancellor's special power
- In the event of any dispute regarding selection of an awardee or any other matter in connection with the administration of the gold medal the Vice-Chancellor's decision will be final and binding on all concerned.
