CIRCULAR

As per the decision of the Executive council of the university decision No.EC/ 30/2011 on 7.5.2011 and MCAER order No. MCAER / Edn- 1/611/2524/dt.29.11.2011 regarding Ph.D. admission for In-service candidates of the University. The eligible inservice academic staff members working on regular establishment may apply for "No Objection Certificate" through proper channel to the Registrar on or before 26.8.2016 in the prescribed proforma (enclosed herewith) for seeking admission to the Ph.D. degree programme during academic year 2016-17 in any Agriculture University of Maharashtra State.

Inservice candidates will be held eligible for admission to Doctoral degree programme only after clearing Ph.D. CET -2016 as per the minutes of meeting held on 29/6/2016 under the chairmanship of Director of Instruction and Dean(Agri.)Dr. PDKV, Akola regarding conducting Common Entrance Test (Ph.D., CET -2016).

As per the Academic Council Resolution No. वि.प. ०३/२०१५ दि. ३१ डिसे.२०१५(Subject No. 5) has recommended to Executive council that the defined age of 50 years of Inservice candidate for seeking admission to Ph.D. degree has been relaxed from 50 to 52 years. Accordingly the candidates will be eligible to apply for said programme upto the age of 52 years.

The NOC issued by the University shall be valid for one year only from the date of issue of N.O.C.for seeking admission to Ph.D. in any University of Maharashtra State .The NOC shall not be issued for next two years to person who fail to seek admission on receipt of NOC. Issue of NOC does not mean that, you are permitted for admission. The candidate has to complete the procedure before relieving this institute.
