**CIRCULAR**

As per the decision of the Executive council of the university decision No. EC/ 30/2011 on 07.05.2011 and MCAER order No. MCAER/Edn. -1/611/2524 dtd. 29.11.2011 regarding M.Sc./M. Tech and Ph. D admission for In-service candidates of the University. The eligible in- service academic staff members working on regular establishment may apply for "No Objection Certificate" through proper channel to the Associate Dean (Instruction) on or before 09/09/2021 in the Prescribed Proforma (enclosed herewith) for seeking admission to the M.Sc./ M. Tech and Ph. D degree programme during Academic year 2021-22 in any Agriculture University.

In-service candidates will be held eligible for admission to M.Sc./M. Tech and Ph. D degree programme only after scoring 55 per cent and 65 per cent marks including weightages in M.Sc./M. Tech and Ph.D. CET - 2021 respectively as per Agriculture Council Resolution No. 01/95/2017, Academic Council Resolution No. विप/०२/२०१८, दि. ४ जानेवारी, २०१८ and the minutes of meeting held on 21/09/2017 under the chairmanship of Director of Instruction and Dean (Agri.) Dr. PDKV, Akola regarding issuance of NOC. No Objection Certificate will be given on the basis of merit formulated by considering weightage of 70 per cent of the CET score and 30 per cent of the CGPA of the student and admissible weightages (Max. five research papers published in NAAS rated Journals).

As per the Academic Council Resolution No. AC/15/2019 dated 16 July, 2019, the minimum eligibility criteria for admission to M. Sc. /M. Tech. degree programme has been relaxed to score 50 per cent marks (In 10 point scale: 5.0 marks) and for Ph. D degree programme it has been relaxed to 60 per cent marks (In 10 point scale : 6.0 marks), including weightages in M. Sc. / M. Tech. and Ph. D CET - 2021, respectively for SC, ST, VJ (A), NT (B), NT (C), NT (D), OBC, SBC, EWS and Physically Handicapped candidates.

As per the Executive Council Resolution No. का. प./५९/२०१६ दि. ०२ डिसे.२०१६, the age limit is 50 years. Accordingly the candidates will be eligible to apply for said programme up to the age of 50 years. In such one of the case, the power of case wise decision to be taken are delegated to Hon'ble Vice-Chancellor.

Further, apart from issuance of NOC for pursuing Doctoral and M. Sc. /M. Tech. degree programme in State Agriculture Universities (SAU'S) of Maharashtra State, the deserving candidates may also apply for NOC for pursuing the Doctoral and M. Sc. /M. Tech. degree


programme in Other State Agricultural Universities in India, preference will be given to the candidate seeking admission in Out of Maharashtra State.

Likewise, only one candidate shall be held eligible either to pursue Doctoral and M. Sc. / M. Tech. degree programme in SAU'S of Maharashtra State or Other State Agricultural Universities in India.

The NOC issued by the University shall be valid for one year only from the date of its issuance of N.O.C. for seeking admission to M.Sc. /M. Tech and Ph. D in any Agriculture University. The NOC shall not be issued for next two years to person who fail to seek admission on receipt of NOC. Issue of NOC does not mean that, you are permitted for admission. The candidate has to complete the office / University procedure before relieving from this Institute.
