CIRCULAR

As per the decision of the Executive Council of the University Resolution No. EC/30/2011 dated 07/05/2011 and MCAER order No. MCAER/Edn- 1/611/2524 dtd. 29/11/2011 regarding M.Sc./ M.Tech. and Ph. D degree admission for in-service candidates of the University. The eligible in- service academic staff members working on regular establishment may apply for "No Objection Certificate" through proper channel to the Associate Dean (Instruction) on or before 30 / 08/2025 in the Prescribed Proforma (enclosed herewith) for seeking admission to the M.Sc./M. Tech. and Ph. D degree programme during the academic year 2025-26 in in the Maharashtra State Agricultural Universities (SAU'S) and Other State Agricultural Universities in India.

In-service candidates will be held eligible for admission to M.Sc. / M. Tech. and Ph. D degree programme only after scoring 55 per cent* and 65 per cent marks and admissible weightages in M.Sc./ M.Tech. and Ph.D. CET- 2025 conducted by the MCAER, Pune or the concerned Agricultural University, respectively as per Agriculture Council Resolution No. 01/95/2017 and Academic Council Resolution No. AC/02/2018 dated 04/01/2018 and the minutes of meeting held on 21/09/2017 and 02/11/2017 under the chairmanship of Director of Instruction and Dean (Agri.) Dr. PDKV, Akola regarding issuance of NOC. No Objection Certificate will be given on the basis of merit formulated by considering weightage of 70 per cent of the CET score and 30 per cent of the CGPA of the student and admissible weightages (Max. five research papers published in NAAS rated journals).

As per the Academic Council Resolution No. AC/15/2019 dated 16 July, 2019, the minimum eligibility criteria for admission to M. Sc. /M. Tech. degree programme has been relaxed to score 50 per cent* marks (In 10-point scale: 5.0 marks) and for Ph. D degree programme it has been relaxed to 60 per cent marks (In 10-point scale: 6.0 marks) in M. Sc. / M. Tech. and Ph. D CET- 2025, respectively for SC, ST, VJ(A), NT(B), NT(C), NT(D), OBC, SBC, EWS and Physically Handicapped candidates and orphan.

As per the Executive Council Resolution No. EC/59/2016 dated 02/12/2016, the age limit is 50 years. Accordingly, the candidates will be eligible to apply for said programme up to the age of 50 years.

Further, apart from issuance of NOC for pursuing Doctoral and M. Sc./M. Tech. degree programme in State Agriculture Universities (SAU's) of Maharashtra State, the deserving candidates may also apply for NOC for pursuing the Doctoral and M. Sc./M. Tech degree programme in Other State Agricultural Universities in India, preference will be given to the candidate seeking admission in Out of Maharashtra State.

The NOC issued by the University shall be valid for one year only from the date of issue of N.O.C. for seeking admission to M.Sc./M. Tech. and Ph. D degree in any Agriculture University. The NOC shall not be issued for next two years to person who fail to seek admission on receipt of NOC. Issue of NOC does not mean that, you are permitted for admission. The candidate has to complete the procedure before relieving this Institute.
