- 1 The applicant shall submit his application in ten Computerized copies of the work or the article published in any reputed scientific Research Journal.
- 2 The applicant should submit the application through **Proper channel** along-with necessary remarks regarding the quality research work.
- 3 If the research work is conducted jointly, the application shall be sent duly signed by all the Co-authors/ Co-workers.
- 4 The application must reach the undersigned latest by **28th November 2025**. The applications received after the above date will not be entertained in any case.
- 5 The selected candidate has to present his research work in front of selection committee through power point presentation.
- 6 Whatever research work the candidate is presenting on that work he should not have received any prize/Award
- 7 In the research project which candidate is presenting should not have more than five candidates as research workers
- 8 Even if a candidate is retired/Ex scientist and has worked in the project his name should be considered in the name of researcher.
- 9 In the event of any dispute regarding selection of an awardee or any other matter in connection with the administration of this prize, the Vice-Chancellor's decision shall be final and binding on all concerned
