The other particulars for the award of the said prize are as under:-

1. Applicant shall submit his application in 10 computerized copies of the work or the article published in any reputed scientific Research Journal.
2. Applicant should submit the application **through proper channel** along-with necessary remarks regarding the quality of research work.
3. If, the research work is conducted jointly, the application shall be sent duly signed by all the Co-authors/Co-workers.
4. The application must reach the undersigned latest by **28th November 2025**. The application received after due date will not be interlined in any case.
5. The selected candidate has to present his research work in front of selection committee through power point presentation.
6. What ever research work the candidate is presenting on that work he should not have received any prize/Award
7. In the research project which candidate is presenting should not have more than five candidates as research workers.
8. Even if a candidate is retired/Ex scientist and has worked in the project his name should be considered in the name of researcher.
9. In the event of any dispute regarding selection of an awardee or any other matter in connection with the administration of this prize, the Vice-chancellor's decision shall be final and binding on all concerned.
