CIRCULAR

As per the decision of the Executive council of the university decision No.EC/30/2011 on 7.5.2011 and MCAER order No. MCAER / Edn- 1/611/2524/dt.29.11.2011 regarding M.Sc./M.Tech and Ph.D admission for In-service candidates of the University. The eligible in service academic staff members working on regular establishment may apply for "No Objection Certificate" through proper channel to the Registrar on or before 19/09/2018 in the prescribed proforma (enclosed herewith) for seeking admission to the M.Sc./M.Tech and Ph.D degree programme during academic year 2018-19 in any Agriculture University of Maharashtra State.


Inservice candidates will be held eligible for admission to M.Sc./M.Tech and Ph.D degree programme only after scoring 55 percent and 65 percent marks including weightages in M.Sc./M.Tech and Ph.D. CET -2018 respectively as per Agriculture Council Resolution No. 01/95/2017 and Academic Council Resolution No. विप/०२/२०१८, दि. ४ जानेवारी, २०१८ and the minutes of meeting held on 21.09.17 under the chairmanship of Director of Instruction and Dean (Agri.) Dr. PDKV, Akola regarding issuance of NOC No Objection Certificate will be given on the basis of merit formulated by considering weightage of 70 percent of the CET score and 30 percent of the CGPA of the student and admissible weightages (Max. five research papers published in NAAS rated journals).

As per the Executive Council Resolution No. का.प./५९/२०१६ दि. ०२ डिसे. २०१६. The age limit is 50 years. accordingly the candidates will be eligible to apply for said programme upto the age of 50 years. In such one of the case, the power of case wise decision to be taken are delegated to Hon'ble Vice-Chancellor.

The NOC issued by the University shall be valid for one year only from the date of issue of N.O.C. for seeking admission to M.Sc. and Ph.D in any University of Maharashtra State .The NOC shall not be issued for next two years to person who fail to seek admission on receipt of NOC. Issue of NOC does not mean that, you are permitted for admission. The candidate has to complete the procedure before relieving this institute.
