In pursuance of the provisions under Statute- 74 (1) and Statute-77 (3) of the Maharashtra Agril. Universities (Krishi Vidyapeeths) Statutes, 1990, read with the provisions of Sub-Section (10) of the Section 18 of Maharashtra Agriculture Universities (Krishi Vidyapeeth) Act, 1983 and on the recommendations of the Selection Board of Academic Staff Members constituted under Statute-76 of MAU (K.V.'s) (Second Amendment) Statute, 2014 in it's meeting held on 24.02.2025, it is hereby ordered that the Agriculture Assistants shown in Col. No. 2 of the table below & presently working under the officer mentioned in Col. The appointment by promotion of the incumbents as mentioned above are effected on the following terms and conditions that:

- 1 The promotions of the above incumbents are effected purely on temporary basis.
- 2 Since the promotion is effected purely on temporary basis, they shall be liable for reversion at any time due to overall reduction of posts or for any other valid reason.
- 3 The above promotions are made purely on temporary basis and subject to decision of the Civil Suits/Civil Petitions pending in the Court and thus they cannot claim any right merely by virtue of the appointment on the said post.
- 4 The incumbents shall be reverted to their original post in case if it is found that they are wrongfully superseded to their seniors.
- If any method direct/ indirect is adopted for disobedience of University order, it will be viewed seriously and in that case he/she will have to forgo the promotion.
- The effect of the above promotions will be effective from the date shown in column No. 6 of above table. However their pay & allowances should be drawn from the date of actual joining on the post of Junior Research Assistant (Facultywise).
- If the present establishment of the incumbent will change with this order, the concerned Head of Office / Controlling Officers are directed that the incumbents promoted should immediately be relieved without waiting for any substitute.
- The promotions of incumbents mentioned at Sr. No. 4, 8 & 12 are subject to the condition that, they should qualify the prescribed examination for Hindi Language in accordance with the Maharashtra government resolution No. Mabhap-2001/Pra.Kra.68/2001/20-B, dated 25/09/2001 within a period of **One year** from the date of this order. The Head of officers of above employees should send the names of employees to Etdarth Mandal. On qualifying the prescribed examination the incumbent shall inform the office along with a copy of the said certificate and ensure the entry of the same in his service book accordingly.

The above order is issued in the interest of University service and should be given immediate effect.
