Recently, the Government of Maharashtra vide its reference mentioned under preamble at Sr. No. 2 has extended the benefit of Career Advancement Scheme to Teachers in Agricultural Universities, Government-Aided Colleges, Affiliated Colleges as per 7th Central Pay Commission and UGC/ ICAR Regulations of teachers and other academic staff in Universities and Colleges and measure for the maintenance of standards in Higher Education, 2018.

The Career Advancement Scheme to the teachers, those who are due or have been awarded in between 01.01.2016 and 12.08.2021 will be governed by the terms and conditions and qualification prevalent at that time of award.

Accordingly, all the concerned academic staff members may submit their proposal in accordance with the circulars issued by the University mentioned under references. All the Teachers in the University are hereby informed that, the teachers who are eligible for the 6th pay Career Advancement Scheme1 stages (Stage I to II, II to III, III to IV & IV to V) on or before 12.08.2021, may submit their proposals for upward movement of Academic Grade Pay under Career Advancement Scheme to their respective Head of Office on or before 18/11/2022 The Head of Office, Controlling Officer and University Head of Department as the case may be should submit such proposals to this Office on or before 30/11/2022 positively. The proposals received after this date will not be considered.

The incumbents are requested to attached the photo copy of the page of Service Book on which the date of joining on the respective post / Stage is mentioned compulsorily.

All the concern should note that, the process of award of benefits of Carrier Advancement Scheme as per the eligibility of 6th Pay Commission recommendation shall not be conducted hereafter. Therefore, all the concern should make sure that, they submit their complete proposals with requisite API marklist within stipulated period.
