Therefore, it is ordered that, the academic officers mentioned in the column No. 3 of the table given below shall work as the **Nodal Officer** for the submission of proposal to the funding agencies mentioned in column No. 2.

The respective Nodal Officer shall scrutinize the project before submission to the funding agencies. The concern academic staff members shall submit the proposal of the projects to the respective Nodal Officer through their Head of office. The Nodal Officer shall scrutinize the project, suggest changes if any after the discussion with the concerned staff members. After fulfillment of the requisite guidelines of the funding agencies, he shall submit the proposal to the Director of Research for further necessary action. The Nodal Officer shall maintain the record proposal receive to him and submitted to the respective funding agencies. The Nodal Officer shall work from their respective offices & shall not request for supporting staff, office infrastructure, etc. and shall work with the available amenities of their respective offices for this purpose. The Nodal Officers shall discharge their duties of Nodal Officer in addition to their own duties.

The Director of Research, Dr. PDKV., Akola shall devise the procedure and issue the necessary circular to this effect immediately.

All the above Nodal Officers shall work as Nodal Officer under the Control of Director of Research, Dr. PDKV., Akola.

The above order is issued in the interest of University services and should be given immediate effect.
