- 2) The leave and other benefits will as per existing norms of the University for the contractual post.
- 3) No accommodation will be provided.
- 4) The appointment will be purely on temporary and Contractual Basis and incumbent shall not have any claim for regular appointment under Dr. PDKV, Akola.
- 5) The terms of the appointment will be co terminus with the period of 11 month from the date of issue of selection order or by 31st March of that Year or earlier based on the performance of the candidate or until the regular post are filled up by the University.
- 6) The incumbents so engaged, shall be liable for discontinuation at any time without any notice on account of unsatisfactory work or any other valid ground.
- 7) The decision of Dean (Engg.) shall be final and binding on the applications.
- 8) It will be open to the Dean (Engg.) not to fill up any of the post now advertised.
- 9) No. TA/DA will be provided for appearing in the interview.
- 10) The time of reporting by candidates for the walk-in-interview will be strictly between 8.30AM to 10.00AM. The candidates who appear after 10.00 AM will not considered for interview. In case, if number of candidates appearing for walk-in-interview are more, then screening exam will be conducted to shortlist candidates and interviews will be continued on next day or on later date.
