5. The terms of the appointment will be co terminus with the period of the project or earlier or based on the performance of the candidate or until the regular post are filled up by the University.
6. No. TA/DA will be provided for appearing in the interview.
7. The time of reporting by candidates for the walk-in-interview will be strictly between 8.30 AM to 10.00 AM. The candidates who appear after 10.00 AM will not considered for interview.
8. The incumbents shall have to join assignment within 10 days from the date of issue of order, failing which the order shall be treated as cancelled.
