

Job Description: For teacher : Have to teach the respective courses, conduct the examinations (in case of PTI), maintain the library (in case of Assistant Librarian) and office related work assigned by Associate Dean and other staff (Full Time for 11 Months).

Other Conditions:

1. No interview call letters will be sent to candidates. Only shortlisted candidates will be communicated by Email/Whats App about link, process and schedule of interview.
2. The appointment will be on contract basis for not more than 11 months and incumbent shall not have any claim for regular appointment under Dr. PDKV, Akola.
3. The term of appointment will be co-terminus with the filling of permanent posts or period of completion of tenure
