Terms & conditions:

1. Age limit: Not more than 38 years. (Relaxation as per rules for SC. ST, DT, NT, OBC and other category)
2. The appointment will be purely on contract basis and the incumbent shall have no legal right to claim his/her regularization/appointment by absorption or otherwise against any regular posts or any further contractual engagement on termination of the scheme/project. Since appointment of incumbents is for full time, they will not be allowed to do any other work or to accept or hold another appointment with or without remuneration elsewhere.
3. The leave and other benefits will be as per existing norms of the University.
4. No accommodation will be provided
5. No. TA/DA will be provided for appearing in the interviews.
6. The period for submitting application and self-attested documents by candidates for the post will be strictly upto 15 days at 5:30 pm. Postal delay or late applications due to any reason should not be considered.
7. The incumbents so engaged shall be liable for discontinuation at any time without any notice on account of unsatisfactory works or any other valid grounds.
