- 1. The above positions are purely on temporary and contractual basis and co terminus with the project subject to satisfactory performance.

- 4. The candidate having essential qualifications would be entertained for the interview. The Candidate who is not able to produce their essential qualification certificates as on the date of interview will not be eligible to attend the interview.
- 5. The candidates are instructed to critically observe the date of interview, reporting time for the posts for which they want to appear. The time of reporting by candidates for the walk-in-interview will be strictly 10.30 AM. The candidates who appear after 10.30 AM will not be considered for interview. If there are large number of candidates, process of walk-in-interview may continue on next day.
- 6. Candidates should be available online as per the slots communicated earlier. If not available after repeated call the candidates may not ordinarily be entertained.
- 7. No TA/DA, accommodation will be provided for attending the interview.
- 8. The incumbents shall have to join assignment within seven days from the date of issue of the order, failing which the order shall be treated as cancelled. They shall have to produce all relevant certificates in original to the concerned officer for verification.
- 9. The SRF and Field Assistant will not be entitled for any regular leave. They are full time worker and are required to adhere to the administrative, financial and disciplinary regulations of the University; hence regular attendance of the JRF will be maintained by keeping an attendance register.
