**Age Limit:**


Senior Research Fellow: 35 years for men, 40 years for women. Age relaxation is applicable as per rules.

**Terms & conditions:**

1. The appointment will be purely on contract basis and the incumbent shall have no legal right to claim his/her regularization/appointment by absorption or otherwise against any regular posts or any further contractual engagement on termination of the scheme/project. Since appointment of SRF is for full time, they will not be allowed to do any other work or to accept or hold another appointment with or without remuneration elsewhere.
2. The term of appointment will be co-terminus with the period of the project or earlier based on the performance of the candidate. Non-maintenance of the discipline or failure to perform the duties assigned will make the SRFs liable for termination.
3. No accommodation will be provided for this post.
4. No TA/DA will be provided to any candidate for attending the interview.
5. Candidate should bring original documents along with a set of attested photo copies (Attested Xerox) pertaining to the following: i) Date of birth ii) Educational Qualifications, SSC and above iii) Experience Certificate (If any) iv) Reprints of research paper published (If any) v) No objection certificate of the employer if employed vi) A passport size photo.
6. No separate call letters will be issued and the time of reporting by candidate for the walk-in-interview will be strictly at 10.00 am on 22.01.2019.
7. The candidates failing to fulfill the eligibility criteria will not be considered for interview.
8. The selected incumbents shall have to join assignment within seven days from the date of issue of the order, failing which the order shall be treated as cancelled. They shall have to produce all relevant certificates in original to the concerned officer for verification.
9. Other terms and conditions will be as per existing norms of the University/ICAR.
10. Notification does not mean that the post will be necessarily to be filled. The discretionary powers will rest with the selection committee for the purpose.
