
Schedule of Walk-in-Interview: Walk-in-Interview for the above-mentioned post will be conducted in the Chamber of Head, Dept. of Irrigation and Drainage Engineering, Dr. PDKV, Akola on 07/01/2025 at 11.00 AM.

Job description: To render assistance to PI and Co-PI for smooth functioning of the project.

Age Limit: Not more than 38 years as on date of Advertisement. (Relaxable to category candidates as per government rule.)

Terms & Conditions:

1. The above position is purely temporary and will be filled on contractual basis. The post is co-terminus with the project, and will be offered initially for a period of 6 months or till availability of grants whichever is earlier and further extendable based on satisfactory performance for the remaining period of the project.
2. Selected candidate will not be entitled to claim for regular appointments/absorption or otherwise against any regular post under Dr. PDKV or in PoCRA Govt. of Maharashtra Non-maintenance of the discipline and failure to perform the assigned duties will make the candidate liable for termination during the appointment period.
3. Candidates should bring their complete bio-data, duly self-attested copies of certificates and mark sheets (along with original documents), Reprints of research paper published (if any), experience certificate in original (if any) and no objection certificate from the employer in case of currently employed elsewhere. Only the candidates having essential qualifications would be entertained for the interview. Candidates who are not able to produce their essential degree completion certificate as on the date of the interview will not be eligible to attend the interview.
4. The candidates are instructed to critically observe the date of interview, reporting time for the posts for which they want to appear as given in schedule of Walk-in-Interview. The time of reporting by candidates for the walk-in-interview will be strictly 11.00 AM. The candidates who appear after 11.00 AM will not be considered for interview. If there are large number of candidates, process of walk-in-interview may continue next day.
5. Candidates should be available online as per the slots communicated earlier. If not available after repeated call the candidates may not ordinarily be entertained.
6. Canvassing in any form will disqualify the candidature.
7. No TA/DA, accommodation will be provided for attending the interview.
8. The incumbents shall have to join assignment within seven days from the date of issue of the order, failing which the order shall be treated as cancelled. They shall have to produce all relevant certificates in original to the concerned officer for verification.
9. The SRF will not be entitled for any regular leave. They are full time worker and are required to adhere to the administrative, financial, and disciplinary regulations of the University; hence regular attendance of the SRF will be maintained by keeping an attendance register.
10. The incumbents so engaged, shall be liable for discontinuation at any time without any notice on account of unsatisfactory work or any other valid ground.
11. The incumbent shall have to give one-month prior notice, failing which one month pay will not be drawn or a pay for the period for which such notice falls short. In the event they leave/resign the assignment before the expiry of the tenure.
12. The decision of PI of the Project will be final and binding in all respects.
