**Terms & conditions:**

1. Age limit: Not more than 38 years. (Relaxation as per rules for SC,ST,DT,NT,OBC And other category)

The appointment will be purely on contract basis and the incumbent shall have no legal right to claim his / her regularization / appointment by absorption or otherwise against any regular posts or any further contractual engagement on termination of the scheme / project.
