
Job Description:

Skill Helper- To render the assistance to PI & Co-PI of the project in implementation of the project protocol for, crop demonstrations should be conducted on, Production & Area expansion under Water Chestnut in Bhandara district with all extension activities, data collection, it's analysis, Monitoring Observation, Data recording, input analysis, Reporting, field visits, samples collection, and time to time allotted work etc.

Terms & conditions:

1. Age limit: Not more than 38 years. (Relaxation as per rules for SC, ST, DT, NT, OBC and other category)
2. The engagement will be purely on contract basis and the incumbent shall have no legal right to claim his/her regularization/engagement by absorption or otherwise against any regular posts or any further contractual engagement on termination of the scheme/project. Since engagement of incumbents is for full time, they will not be allowed to do any other work or to accept or hold another engagement with or without remuneration elsewhere.
