1. No accommodations will be provided.
2. No TA/DA will be provided for appearing in the interview.
3. Number of vacant posts may be changed at any time.
4. Candidate should bring original documents and one set of attested photo copies (for attachment with application form) pertaining to the following:  
i) Date of birth ii) Educational Qualifications, SSC and above iii) Reprints of research paper published (if any), iv) Experience certificate (if any) v) No objection certificate of the government employer if employed, any other certificate in support of candidates and two passport size photos.
5. **The candidates are requested to fill the application form cautiously which is given with the advertisement and also attach all the necessary attested photo copies of documents. Bring the filled application form enclosed with necessary attested photo copies of documents at the time of Walk-Interview.**
