Terms and Conditions

1. No TA/DA will be provided for appearing the interview
2. Candidate should bring original documents along with a set of attested photo copies pertaining to following. i) Date of birth ii) Educational qualifications: SSC and above iii) Reprint of research papers published (if any) iv) Experience certificate (of any) v) No objection certificate of the employer, if employed vi) and other relevant documents
3. The time of reporting by candidate for the Walk-in-Interview **will be strictly 10.00 am to 11.00 am.**
4. The candidates are instructed to critically observe the date of interview, reporting time for the post for which they want to appear as shown in above table.
5. **The engagement will be on purely temporally on contractual basis and the incumbent shall not have any claim for regular appointment under Dr. PDKV, Akola.**
6. The term of engagement will be for 11 months from the date of issue of engagement letter.
7. Candidates shall have to produce all relevant certificates in original for verification.
8. The incumbents if engaged shall be liable for discontinuation by university any time without any notice on account of unsatisfactory work or any other valid ground.
9. The Farm Machinery Testing and Training Centre, Department of Farm Power and Machinery, Dr. PDKV, Akola reverses the right to decrease the positions.
10. The selected candidate will be required to give an undertaking that he/she will not leave the assignment half way and shall complete the work in the prescribed time limit in this regards the candidate selected for the post will have to execute bond on stamp paper about his contractual engagement.
11. The selection committee will interview only eligible candidates who fulfills the eligibility criteria. The applicants will have to appear for the interview on scheduled date and time at their own cost.
12. If candidates are more, written test will be taken for screening the candidates and after screening selected candidates will be interviewed by the Selection Committee.
13. The selected candidates will have to work at Farm Machinery Testing and Training Centre, Dept. of Farm Power and Machinery, Dr. PDKV., Akola. and within and outside state in the field/ laboratory and office, as per the mandate of the center, for the entire term as full-time worker and they will not be allowed to accept any other appointment/assignment during this period.
14. The notification does not mean that all the posts will be necessarily filled. The discretionary power will rest with the Selection Committee constituted for the purpose.
15. The appointment of the selected candidate for the said post shall be a tenure appointment and purely contractual on temporary basis (Eleven months) and likely to be terminated at any time without assigning any reason thereof and candidate shall not have any right of claiming permanency benefit of the said post or such posts by virtue of this appointment. Actual working place of the candidate will be FMTTC, Dept. of FPM, Dr. PDKV., Akola. However, as a part of duty, the candidate will have to perform field, research, extension and office duties besides the work of testing of agricultural implements and machinery developed by entrepreneurs etc.
16. If any false information/documents are submitted by the applicant, he/she shall be disqualified at any stage.
17. Canvassing in any form will be disqualified at any stage.
