- 3 Age Limit- Not more than 38 years (Relaxation as per rule for SC, ST, DT,NT, OBC and other category)
- 4 The leave and other benefits will as per existing norms of the University for the contractual post.
- 5 No accommodation will be provided.
- 6 The appointment will be purely on temporary and Contractual Basis and incumbent shall not have any claim for regular appointment under Dr. PDKV, Akola.
- 7 The terms of the appointment will be co terminus with the period of the project or earlier or based on the performance of the candidate or until the regular post are filled up by the University.
- 8 No. TA/DA will be provided for appearing in the interview.
