6. No. TA/DA will be provided for appearing in the interview.
7. The time of reporting by candidates for the walk-in-interview will be strictly between 11.00 AM to 12 PM. The candidates who appear after 12.00 PM will not considered for interview.
8. The incumbents shall have to join assignment with in 10 days from the date of issue of order, failing which the order shall be treated as cancelled.
