Preamble

Dr. Panjabrao Deshmukh Krushi Vidyapeeth, Akola was established on 20th October, 1968 and named after the illustrious son of Vidarbha Dr. Panjabrao (alias Bhausaheb) Deshmukh. The university is entrusted with the responsibility of agricultural education, research, extension education and seed production. It has the jurisdiction of 11 districts of Vidarbha region of Maharashtra state comprised of three agro climatic zones. Agriculture in Vidarbha is characterised by dryland farming with 86 per cent of the cultivated area dependent on monsoon. Vidarbha region occupies 27.91 % (64.49 Lakhs ha) area under cultivation of Maharashtra state. The major crop are Cotton, Soybean, Pigeonpea and Paddy in kharif and gram in rabi season.

The university has two large farms viz., Central Research Station, Akola and Central Demonstration Farm at Wani Rambhapur. Besides, has Agriculture Research Station (13), Agricultural Technical Schools (8), KVKs (7) which caters the need of research, extension work and seed production activities. The university has developed 169 varieties/hybrids of different crops since its inception. Among them several varieties/hybrid has been reached to the farmers field at state and national level and added feather in the cap of University viz. Cotton (PKV Hy-2, PKV-081, AKA-5 & AKA-7), Sorghum (CSH-14 & PKV-Kranti), Pigeon pea (PKV Tara), Green Gram (TARM-2 & PKVAKM-4), Black Gram (TAU-1), Chickpea (Jaki-9218, PKV Kabuli-2 & Kabuli-4) and Groundnut (TAG-24).

In the light of IPR regime, Dr. PDKV, Akola has received the certificate of appreciation for submitting the highest number of extent notified varieties for PVP-entitlement from Protection of Plant Varieties and Farmers' Right Authority, Department of Agriculture and Cooperation and Farmers Welfare, Ministry of Agriculture and Farmers Welfare, Government of India, New Delhi on 30th June, 2016.

About the workshop

'The Protection of Plant Varieties and Farmers' Right Act, 2001 (PPV&FRA)' is an act of the parliament of India enacted to provide for the establishment of an effective system for protection of plant varieties, the rights of farmers and plant breeders and to encourage the development and cultivation of new varieties of plants. Public-Private partnership for commercialization is a collaborative efforts between the public and private sectors in which each sector contribute to planning, process, resources and activities needed to accomplish the shared objective.
