## SECTION - I (PART-A)

### INSTRUCTIONS TO E-TENDERERS, TERMS AND CONDITIONS OF E-TENDER:

#### INVITATION OF OFFER:

1.1 Sealed e-tenders (in Two Bid System) are invited for the **Head, Department Fruit Science and Chairman, preparation of salable graft and seedling** as stated in D/FS/Chairman/E-Tender/  
Nursery prod./965/2023 Date: 29/03/2023

#### ELIGIBILITY CRITERIA:

- 2.1 This is time bound activities hence participant must have prepare the graft and seedling and supply the material in stipulated period given in the tender or as per order issued from time to time by Dr. PDKV.
- 2.2 E-Tender complete in all respects should be submitted in Two Bid System online at the e-Tendering portal of Govt. of Maharashtra at [www.mahatenders.gov.in](http://www.mahatenders.gov.in). If possible the e-tenders would be opened **on 04/05/2023 at 11.00 hrs.** (Technical Bid) in the presence of e-tenderers/e-tenderer's representative present at the time of opening.
- 2.3 Technical Envelope containing all the necessary documents in the form of PDF files / Scanned images. These documents need to be digitally signed by authorized digital signature and uploaded during online bid preparation stage. Original copies shall be kept ready at the time of opening of the tender.

#### TWO BID SYSTEM:

- 3.1 During online submission of e-Tender, the copies of all e-tender documents as detailed below along with the scanned copy/copies of PRN Number received from bank against the online payment of e-tender fee and EMD must be uploaded. The copy of the PRN slip towards EMD must be submitted in the technical bid online and not in physical form. The technical-bid must be digitally signed by the e-tenderer; else it is liable for rejection. In case of physical submission, only Technical Bid has to be submitted and **Price- Bid has to be submitted online and not in physical form.**
- 3.2 Technical Bid for online submission

The following documents should be uploaded in the Technical Bid

- a. The scanned copy of PRN Number received from bank against the online payment of E-Tender fee (Non-refundable) and EMD must be uploaded during online submission.
- b. In case of party claiming SSI or MSME exemption the option "EMD Exemption" should be opted while uploading the tender.
- c. Valid Exemption Certificate of SSI, MSME, Co-operative Units and Govt. Parties should be submitted in the physical form.
- d. Acceptance of Terms and conditions of the e-Tender form (Technical Bid) Section-II (Part-A) Technical Details Section-I (Part-B) along with relevant documents digitally signed for online submission and duly signed for physical submission.

### 3.3 PRCIE BID FOR ONLINE SUBMISSION ONLY:

**The Price-Bid has to be submitted online only and not in physical form.** This bid must be digitally signed along with all the details filled in else the tender is liable for rejection.

3.4 Tenderers must affix seal and put address on Technical Bid Envelope.

3.5 If relevant papers / documents are not found in Technical Bid envelop or even if price bid is found in Technical Bid, then also the tender will be considered as non eligible and will stand rejected.

### **REJECTION OF E-TENDER:**

4.1 Any party not fulfilling the conditions of Technical Bid shall be out rightly rejected.

4.2 Offers with alternatives to the specification given in the tender will be out rightly rejected.

4.3 Conditional tender shall not be considered. Printed terms and conditions of the tenderer shall not be considered as forming part of their tenders. In case any terms and conditions of the Contract applicable to this invitation to tender are not acceptable to tenderers, they should clearly specify deviation in their tender. Dr. PDKV reserves the right to accept or reject them. Dr. PDKV shall not be bound to give reasons for the refusal to consider the tender with deviations.

4.4 The Tender analysis will be done and technically and commercially eligible parties as decided by the competent Authority of Dr. PDKV will only be considered eligible. The process of competitive bidding involves the right to implement suitable evaluation process as considered best in the interest of Dr. PDKV.

4.5 Price Bid of eligible parties will only be opened.

4.6 No erasure or alteration is permitted in the documents submitted by e-Tender Parties (either in Technical or Price Bid), any such erasure or alteration if done, should be countersigned, failing which tender is liable for rejection.

### **OPENING OF TECHINCAL BID AND PRICE BID:**

5.1 First of all **Technical e-Envelope T-1** of the tenderer will be opened to verify its contents as per requirements. If the various documents contained in this envelope do not meet the requirements a note will be recorded accordingly by the tender opening authority and the said tenderer's Commercial Envelope C-1 will not be considered for further action but the same will be recorded. Decision of the tender opening authority shall be final in this regard.

5.2 The Price Bid of all eligible parties will be opened online as stated in tender (if possible), if not possible it will be opened on suitable date which will be informed to the tenderer participated or will be displayed on our website.

### **RATE OFFER:**

6.1 The rates offered should be for items specified in tender along with the terms and conditions given and should be:-

- a) Free door delivery with unloading at the offices under the jurisdiction of Dr. PDKV, Akola and including all charges/Taxes etc.
- b) Inclusive of all Taxes (including turnover tax), Duties (Excise, Special Excise, Service Taxes, Cess), Packing and forwarding charges, GST etc.

**PRICE NEGOTIATION:**

7.1 All the right for price negotiation is reserved by the Dr. PDKV. Committee is free to decide the course and method to be adopted for the negotiation purpose.

**SPLITTING OF TENDER:**

8.1 Committee reserves the right to split the order amongst more than one party at the tender lowest rates, without assigning any reason thereof. The party who offered lowest rate (L1) will be given preference and competent authority will decide the number of parties amongst whom the order should be split.

**RE-TENDER:**

9.1 The Item shall be re-tendered under the situation that during evaluation of tender (Technical Bid) the number of eligible tender parties found are less than three.

9.2 Extension of time and date for acceptance of Tender shall be considered, keeping in view the No. of tenders received up to due date and time.

9.3 The item shall be re-tendered when the lowest rates received in the tender are not acceptable to Tender committee, Dr. PDKV. Akola.

**CLARIFICATION REQUIRED BY E-TENDERER:**

**EARNEST MONEY DEPOSITE:**

11.1 Earnest money deposit as stated in tender notice should be paid online during uploading the e-tenders on the e-tendering portal of Govt. of Maharashtra [www.mahatenders.gov.in](http://www.mahatenders.gov.in). The scanned copies of PRN number received from bank against the online payment of EMD must be uploaded during online.

11.2 No Interest will be allowed on the Earnest Money (EMD) from the date of its receipt until it is refunded.

11.3 Earnest money shall be paid via online using NEFT/RTGS or payment gateway mode. After Tender opening, the EMD of the unsuccessful bidder will be returned to account provided by the bidder during the bid preparation as given in challan under Beneficiary Account Number by the online system.

11.4 **Earnest money in the form of cheques or any other form except above will not be accepted.**

**FORFEITURE OF EMD:**

12.1 In the event of a tenderer, whose tender is received within the closing date and time of the tender as specified, withdrawing his tender before the receipt of final decision or in the event of tenderer whose tender has been accepted, failing to execute an agreement within 7 days from the date of giving the offer and/or failing to deposit Security amount within 10 days from the date of executing an Agreement, the Earnest Money deposited by such tenderer shall be forfeited without any intimation and in the later case the tender also shall be cancelled and order will be

placed with other party/parties either from tender process or from open market and any excess expenditure incurred by Dr. PDKV shall be recovered from the defaulting party.

12.2 When the party has declared in Technical Bid that his offer is as per the tender specifications but eventually differ in specifications given in Price-Bid his offer shall stand invalid and the EMD will be forfeited.

12.3 When the party is declared in Technical Bid that party has available all materials as per specification and make for the erection of protected structure quoted and when the same is not confirmed during the visit by committee of Dr. PDKV officials for technical verification at particular working site the EMD of such parties will be forfeited.

#### **AWARD OF TENDER, EXECUTION OF AGREEMENT:**

The fees of tender document will be non-refundable. Tenderer has to deposit Earnest Money Deposit (EMD) amounting Rs. 100,000/- (Rs. One Lakh Only) via online payment mode.
2. A tenderer will not be permitted to withdraw or modify or amend the contents of the tender once submitted.

In case of any dispute arising between the parties in respect of terms of contract and matters arising out of contract, it shall be referred to the sole arbitration of Dean, Faculty of Horticulture, Dr. PDKV, Akola whose decision shall be final and binding upon the parties. Such arbitrator shall have all necessary power under the Indian Arbitration and Conciliation Act. 1996 and the said arbitration proceedings shall be conducted at Akola only under the provisions of the said Act, and the decision of Dean Faculty of Horticulture, Dr. PDKV, Akola shall be subject to general power of superintendence of competent authority of the University.

## **B. SPECIAL TERMS AND CONDITION**

1. Experience required for bidder: The bidder shall be any person/firm/agency/public private partnership firm, and it should have preferably minimum three years of experience of running horticulture nursery in any government, semi government, local bodies or any reputed the government licensed private organization.
2. Financial Position required for bidder: The bidder shall be person/firm/agency/public private partnership firm, and it should have More than one Corers (Rs. 01.00 Corers) turn over in single financial year. It should mandatory to produce the documents of turnover of last three financial years, duly certified by Chartered Accountant along with any yearly
3. The tenders are invited from the interested bidder in two bid system. The bidder has to provide his all requisite information in the technical bid. The bidder has to provide two bids; technical and commercial bid. Every year the university announce its price list of grafts/seedlings of fruit crops. The farm produced in the form of planting material is supposed to be sale out at the rate declared by the University. These rates valid for one complete year and it may be regularly revised on yearly price the bid documents.

The successful bidder shall have to sale out the grafts/seedlings with the rate prescribed by the University.

**The University has fix selling rates of grafts and seedling every year in the beginning of a planting season.**

**The bidder has to provide its price in the form of the percentage (%) of cost of preparation of graft and seedling as prescribed by University every year. Annexure-I (Commercial E-envelop (C-1) through online mode only.**

The rate of grafts and seedlings declared by competent authority for the year 2022-23 is provided with this document as Annexure-II.

Bidder should not place any commercial statement (Scanned, PDF & JPG) documents in technical section.

4. It is the sole responsibility of the successful bidder to execute total work assigned to him during the contract period. The responsibility of minimum wages act, different types of labour laws, State Govt. Central Govt. and all other rules and regulations applicable to labours is lies with the contractor. The College or University of Department will no way concern to violation of the labour rules and regulations and any damages upon it. All the terms and conditions, rules and regulations regarding labourers are to be strictly followed by the contractors with due responsibility. It is the full responsibility of the contractor for any accident, natural calamity, excessive rainfall, death and any unavoidable circumstances happens during the period of contract. The life/accidental insurance policy for labour is necessary.
5. The successful bidder has to deposit 3% of the total tender amount as a security deposit through cheque to the office as early as possible to get a work order from the concerned authority.

6. In any case, subletting of the contract shall not allow. If it will found that, the Contractor subletting the contract during the contract period, it will be viewed seriously and security deposit may be forfeited by Department without any prior notice and all the materials, implement, machinery and inputs of the contractor will not be handed over to contractor at any cost.
7. During the period of contract, if any misbehaviour, irresponsibility, hindrance and disturbance by the contractor or his associates & labours, the work order stand cancelled & security deposit will be forfeited without any prior notice.
8. After receipt of the work contract order, if the contractor fails to prove his capability of work, the contract may be cancelled without any prior intimation. Under such situation, the next contractor in the bid will be entertained as a new contract if he agrees to work as per the rate quote by the first contractor. If not so the third contractor in the bid may be considered for the contract. In this case all the rights are reserved with Chairman & Head, Department of Fruit Science, Dr. PDKV, Akola
9. The successful bidders shall have to initiate the nursery work immediately as soon as the work order issued to him. Regarding supply of nursery materials only the bud sticks from the mother plants and the seeds for raising rootstocks particularly in mandarin orange, sweet orange and Acid lime will be provided by the authority. Also the material required for nursery e.g. garden soil, fertilizers, FYM, polybags, insecticides, pesticides, weedicides, nursery equipment's, implements, machineries and all other such materials etc. should be procured by the contractor himself at his own expenses, it is the sole responsibility of the contractor to provide such material in time as per the instructions and supervisions of experts of this department.
10. Shade net houses, control polyhouses, soil solarisation platform are presently available with the different irrigation facilities and are allowed to be used by the contractor however, the further maintenance and repairing and maintenance of the existing net houses and further additional irrigation facilities, pipe lines, electric equipment's, farm implements and routine operators for the nursery management should be done by Contractor at his own cost with his full responsibility. If existing protected structure shall become short and there will be the necessity of extended part of shed net, urgent repairing of existing shed net, it should be installed by the contractor with prior permission/sanction and approval of concerned authority as per the scientific norms of the University.
11. After the approval of work contract, the contractor has to deposit 3% of the total tender amount as a security deposit through cheque to the office as early as possible to get a work order from the concerned authority.

### **C. PERIOD OF CONTRACT**

The successful bidder shall eligible to make contract to undertake the proposed work. The validity of contract shall be for **five (5) years** from the date of issue of work order. It shall be extended for next five years after review of satisfactory performance of contractor in contract period



by the authority. At the end of contract, the temporary as well as any assets created by contractor shall be totally retained by University. It shall not be returned back to the Contractor.

**D. LOCATION AND NATURE OF WORK**

1. The successful bidder shall have to start the work at Nursery area, Near Krushi Nagar, Department of Fruit Science; Dr. Panjabrao Deshmukh Krishi Vidyapeeth main campus, near NH-6 highway, Akola, MS. Bidder shall be permitted to allow making use of existing protected structures and advanced irrigation facilities as designated by this department.
