

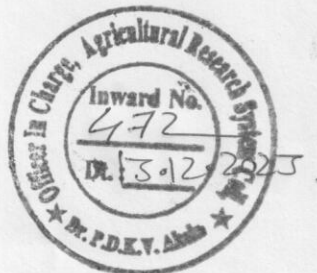



2. On the envelope following should be clearly mentioned in **BLOCK LETTERS** Quotation for.....Enquiry letter No. and date.....
3. Items available in ready stock and which can be supplied on placing firm order may only be quoted.
4. Rates should be inclusive of C GST and S GST.
5. Prices/rates quoted should be "ALL INCLUSIVE" including of all taxes, levies, expenses, tariffs etc. and **FOR** at Dr. PDKV. Akola.
6. Detail features specifications, make, models, manufacturer, accessories required along with the market literature and photographs should accompany the quotation of the items for which rates are quoted.
