Terms and conditions of supply.

1. The quotation should be in the name of Head, Department of Plant Pathology, Dr.PDKV, Akola.
2. The quotation should reach in this office on or before 06.12.2024
3. The quotation will be accepted on all working days between 10.00 am to 5.30 pm
4. The labour Contractor should have all necessary documents and will have to submit in the office.
5. The contractor should have registered permission for the said contract.
6. The rates Quoted for skilled and unskilled labours should be inclusive of all taxes.
7. The Contractor will be responsible for the payment towards labours within the specified / mentioned period.
8. University will not be responsible towards any claims and complaints of labours.
9. The Contractor will be responsible for the management of all skilled / unskilled, male / female labours required for various types of labourious work as per the need to Department.
11. The labours provided should have earlier experience of doing specific type of work.
12. While doing work in Biofertilizer unit and laboratory if any machinery of instrument gets damaged due to the negligence or purposeful act of labours the contractor will have to pay for the damage amount.
13. While working on Field, Laboratory, Biofertilizer unit, office premises, Garden etc. if any accident occurs leading to minor or major injuries, or death calamity of any contractual labour , University / Head, Department of Plant Pathology / any Staff member of Department will not be responsible for any such unpleasant situation the contractor should take care of the situation.
14. The labourers should complete the daily tasks allotted to them within given time otherwise their

- payment will not be drawn by the Department.
15. Any dispute regarding will be solved Head, Department of Plant Pathology and Dean (Agri), but final decision will be commanded by Dean (Agri.) and all will have to compulsorily accept it.
 16. The rates quoted for contractual labourers will be valid for One Year or till the end of financial year i.e. till 31st March as approved by Head Plant Pathology and Dean (Agri.), Dr.PDKV, Akola.
 17. The skilled and unskilled laboures provided should be an Indian citizen and have attained age of 18 years or more but less than 60 years, and should be physically and mentally fit to do all type of work, free from any deadly contagious disease and any type of disability.
 18. Identity proof / residential proof / aadhar etc. of the labours should submitted in Office.
 19. The Labour should not be working in any Government / Semi Government organization and neither should be involved in any crime of illegal affairs.
 20. Contractor will have to deposit 10 % amount of total bill to be paid with Head, Department of Pathology
 21. While implementing the quotations/contract procedure, Head, Department of Plant Pathology has whole right to stop/ cancel the procedure without giving notice or prior information and will not be commuted to give explanation for the act.
 22. Head has whole power to accept the contract partially or completely.
 23. If two quotations are same then Head has power of selection.
 24. If all terms and conditions are accepted, contractor will be responsible to sign contract on RTs. 100/- stamp paper with the Head.
 25. In any case contractor or contractual labour will not have any type of claim especially regarding permanent job or any back log payment installment, on Department of Plant Pathology or Dr. PDKV , Akola University.
 26. Contractor will be responsible for any type of fraud / incomplete/ wrong documents submitted to the Head, and will be held guilty for the offence, also will be subjected to the trial as per the rule.
 27. All the payment will be done through bank only so, proper bank related documents should be Submitted.
 28. In case of any conflict all legal action will be entertained under Akola Jurisdiction only.
