
Kindly follow the instructions given below with terms and conditions.

4. The sealed quotation should be in the name of **Head & PI, Agri-Business Incubation Centre** also mention '**Regarding supply of Labor on Daily wages**' on the envelope
5. The right to accept whole or part of the quotation or reject without assigning any reason is reserved with the undersigned.

Terms and Conditions:

1. Given work will be on daily basis and as per the Government norms the daily working will be of 8 hours.
2. If it will be not possible for labour to present on any of the working days, in that situation alternative arrangement should be made by the firm for that day.
3. As the given work is completely on contractual basis, labour or worker will not be enlisted in seniority list or there will not be any kind of provisions to sign them on attendance muster for maintaining their attendance and work record.
4. The undersigned below has the right to terminate the appointment which will be done under this contract before the completion of said time period.
5. Payment of Labour or Worker will be paid as per Minimum wages Act.

6. All the responsibilities to provide Accidental Insurance, Provident Fund or any other benefits as per Government decisions will be completely towards the Labor Contractor.
