- 3. The earnest money will be accepted in the form of TDR/FDR for a period of 12 months issued by any Nationalized / Scheduled Bank & in the name of The University Engineer, Dr. PDKV, Akola (In envelope No.1). No exemption shall be allowed in this regard, except the Contractor Registered under Unemployment Engineer Scheme vide GR No. CAT1090/CR21 EMA-2 Mantralaya Mumbai 400 032 Dt. 7 Sept. 1995 & EMD exemption certificate issued by the PWD/CPWD.
